As a *Deputy*, he was the Rapporteur Member of Convertibility Act, Liabilities Consolidation Act, Financial Administration Act and Budget Act corresponding to years 1992, 1993, 1994, 1995, 1996, 1997, 1998, and 1999 and of all laws related to tax issues

dealt during the Presidency of Committee. He was the author of numerous bills that Congress had passed and became lawful Acts.

As a *Senator*, he was the Rapporteur Member of Emergency Act that ended the Convertibility Act; also he was the author of the Emergency Floods Act of Santa Fe Province and other bills such as Solidarity Banking, Small and Medium-scale Enterprises Financing, other bills related to water administration in Argentina, Promotion and Development of Children Playing, IT Alphabetization, Investment Promotion Regime in rural housing and Teleworking Contracting.

Lectures and Seminars: During his career , he has delivered various lectures and participated as speaker in many occasions, among which it is to be highlighted those organized by Asociación Argentina de Presupuesto Público (Argentine Association of Public Budget), Auditoría General de la Nación (Auditing Office of the Nation), Price Waterhouse, Institute for International Research S.A., O.E.A and various professional councils. He also has been a speaker invited by main universities and foundations of Argentina.
