## Progress Report November 2011

Presidency: Dr. Oscar Lamberto Auditoría General de la Nación ARGENTINA

### BACKGROUND

COMTEMA is the Working Group on Environmental Auditing of OLACEFS (the Latin America and the Caribbean, Supreme Audit Institutions Organization),

COMTEMA was created in November 1998 at the 8th General Assembly of OLACEFS. Its mission is to support the development of environmental audits among the Supreme Audit Institutions (SAIs) members of OLACEFS, promoting environmental management control, and the strengthening and integration of these SAIs.

COMTEMA was coordinated by the SAI of Brazil since its creation until April 2009, when the SAI of Argentina was elected President of the Commission.

At the moment, the Commission is formed by the following SAIs: Argentina, Brazil, Bolivia, Colombia, El Salvador, Mexico, Panama, Paraguay, Peru and Venezuela. However, some other SAIs participate in some of the activities of the Commission and attend the meetings as observers.

The following information presents an abstract of the progress made between April 2009 and November 2011 in accordance with the Work Plan 2009-2011, as well as with the agreements reached during meetings and communications among members.
